Responsibilities:

The management team at AC Nursing and Health Services are responsible to work safely and comply with the requirements of occupational health and safety legislation, including, among other things, ensuring that safe and healthy Occupational Health & Safety Policy and work conditions are maintained in their assigned work area and with the individuals they supervise.

The management team at AC Nursing and Health Services shall ensure that persons under their direction are made aware of, and comply with, all applicable health and safety work legislation, internal standards, programs, and procedures.

Professional Practice Leaders are to investigate all health and safety hazards of which they become aware and take timely and appropriate action to mitigate risk.

All workers are responsible to work safely and comply with the requirements of occupational health and safety legislation, established internal standards, programs, and procedures. In the interest of the health and safety of all members of the community, workers have a duty to report health and safety hazards or legislative contraventions immediately to their supervisor or someone in authority. AC Nursing and Health Services is committed to reviewing this policy at least annually.

COMPLIANCE AND REPORTING

The responsibility for applying, interpreting, and monitoring compliance with this policy rests with Human Resources. Unit supervisors are responsible for identifying and addressing violations of this policy.
